

READING FESTIVAL 2008 - CAMPERVAN & CARAVAN CONDITIONS

Access and use of the campervan area is provided subject to the following Festival Republic Terms and Conditions. Purchasing a permit constitutes your acceptance of these Terms and Conditions.

Please read them carefully

- Separate fields for ticket holders to park campervans and caravans are available adjacent to the Festival site. This designated area of the site is the only place where ticket holders can sleep in vehicles - **these vehicles will only be allowed in the fields if they have living accommodation with fitted sleeping facilities and either fitted cooking or washing facilities.**
- No other vehicles will be allowed entry under any circumstances, not even late replacement vehicles in the case of a breakdown – sorry. Vehicles can not be towed onto the field. **Unsuitable vehicles, including unconverted vans, with tickets for the campervan fields, will not be allowed entry and will be sent to one of the festival car parks** – and, as it is contrary to our licence, security patrols will not permit sleeping in any vehicles in these car parks.
- Trailer tents, campervans and caravans are permitted.
- Campervan/Caravan permits are only valid with WEEKEND CAMPING TICKETS. Each person with the vehicle must have a Weekend ticket and ONLY weekend ticket holders will be permitted in the campervan area. Tickets and permits must be bought in advance.
- Cars can not be parked next to campervans/caravans; all vehicles other than towing vehicles must be parked in the car parks. Towing vehicles must remain in the same field as campervans/caravans, not parked elsewhere.
- Campervans/caravans will be parked in rows.
- There will be limited space for **ONE tent OR an awning** to be erected per campervan/caravan.
- There is NO water or electricity hook available; however there will be a water point in the campsite for general use.
- No vehicles are to be parked in the fire lanes at any time.
- No trading of any kind is permitted from campervans/caravans.
- No sound systems are to be operated in the campervan/caravan fields. Anyone found operating such systems may be liable to eviction.
- **Excessive amounts of alcohol/cigarettes i.e. more than for personal consumption and any alcohol in the possession of anyone under 18 years of age is not permitted.**
- No animals are permitted anywhere at the Festival.
- Persons suspected of carrying items which may be used in an offensive or dangerous matter, or carrying out illegal activities may be searched including their vehicle.
- All waste-water must be put in the containers provided. It is illegal to pour waste-water onto the ground, into a sumo or into a stream. This will be monitored by the Environment Agency. Campervan/Caravan ticket holders must use the toilets

provided and must not pollute streams or hedges. Toilets are provided in the camping area for your use, but there are no portable toilet emptying points. All waste must be removed from site.

- Open fires are NOT permitted. Barbecues can be used in these fields, but they must be at least 3m away from any vehicle.
- The fields must be clear by 12:00PM NOON on the Bank Holiday Monday (August 25th). All remaining vehicles will be removed.
- All litter must be cleared and put into litter bins or recycling bins.
- Please respect The Country Code at all times.
- The Campervan/Caravan fields will be in White campsite and will be patrolled by security staff. Facilities provided include water, waste-water containers, toilets and a bar & food trader open 23 hours a day. There is no electricity provided for field users.
- Tickets to park in these fields are available for an additional fee, provided you purchase weekend tickets for the Festival at the same time. (See www.readingfestival.com/tickets about how to purchase both weekend tickets and tickets for Campervans/Caravans/trailer tents)
- The only access to the Campervan/Caravan fields is via White. A windscreen routing sticker will be sent to you with your Campervan/Caravan ticket with directions.
- The security staff will also check for any items not permitted on site, as specified in the Terms & Conditions on weekend tickets. Security staff will confiscate any such items and may refuse entry to the site. The decision of the security team will be final.
- Manufacturers' trailers tents will be permitted in one of the Campervan/Caravan fields.
- No tents may be erected between vehicles for fire safety reasons. There will be limited space for Campervan/Caravan field ticket holders to camp immediately behind their vehicles.
- The Festival does not rent campervans/Caravans to ticket holders, or have any arrangements with contractors to rent Campervans/Caravans to ticket holders. If ticket holders arrange privately to rent a caravan, it can be sited in these fields. The ticket holder will need to purchase a Campervan/Caravan ticket with their Festival ticket and ensure that the contractor renting the Campervan/Caravan is given this Campervan/Caravan ticket and routing sticker for the fields. The contractor will then need to arrange access to the fields by contacting the Campsite Manager through the Festival Site Office. The ticket holder will need to arrive at the Festival by public transport or purchase a car park ticket for the public car parks so that they can gain access to the site themselves.
- Security staff may evict those that do not adhere to the conditions above, and may also confiscate their festival weekend tickets and any contraband items.
